We believe that children should wear uniform in school. We would like children to have pride in being a part of Stoneydelph Primary School and in maintaining a well-dressed and smart appearance.

1. Aims

This policy aims to:

- Set out our approach to requiring a uniform that is of reasonable cost and offers the best value for money for parents and carers
- Explain how we will avoid discrimination in line with our legal duties under the Equality Act 2010
- Clarify our expectations for school uniform

2. Our school's legal duties under the Equality Act 2010

The Equality Act 2010 prohibits discrimination against an individual based on the protected characteristics, which include sex, race, religion or belief, and gender reassignment.

To avoid discrimination, our school will:

- Avoid listing uniform items based on gender, to give all pupils the opportunity to wear the uniform they feel most comfortable in
- Allow all pupils to have long hair (though we ask for this to be tied back)
- Allow pupils to request changes to swimwear for religious reasons
- Allow pupils to wear headscarves and other religious or cultural symbols
- Allow for adaptations to our policy on the grounds of equality by asking parents to get in touch with Mrs Parsons, Headteacher, who can answer questions about the policy and respond to any requests.

3. Limiting the cost of school uniform

Our school endeavors to make sure that the uniform we require is affordable, in line with statutory guidance from the Department for Education on the cost of school uniform.

We understand that items with distinctive characteristics (such as items with the school logo) cannot be purchased from a wide range of retailers and that requiring many such items limits parents' ability to 'shop around' for a low price.

We will take all possible steps to ensure our uniform:

- Is available at a reasonable cost
- Provides the best value for money for parents/carers

We will do this by:

- Carefully considering whether any items with distinctive characteristics are necessary

- Limiting any items with distinctive characteristics where possible for example, by only asking the jumper/cardigan features the school logo
- Avoiding specific requirements for items pupils could wear on non-school days, such as coats, bags and shoes
- Keeping the number of optional branded items to a minimum, so that the school's uniform can act as a social leveler
- Avoiding different uniform requirements for different year/class/house groups
- Avoiding different uniform requirements for extra-curricular activities
- Making sure that arrangements are in place for parents to acquire second-hand uniform items
- Avoiding frequent changes to uniform specifications and minimising the financial impact on parents of any changes
- Consulting with parents and pupils on any proposed significant changes to the uniform policy and carefully considering any complaints about the policy.

We ask that all children wear the uniform and encourage them to maintain a good standard of clean and tidy dress in school.

The school colour is navy blue.

The uniform is:

- Navy blue cardigan or jumper (with school logo preferable)
- Plain white polo shirt
- Black or grey skirt, pinafore, trousers or shorts
- Blue check dress (summer)
- Plain black smart school footwear (no trainers)

PE Kit:

- Plain white t-shirt
- Plain black shorts/jogging bottoms
- Plain navy blue hoodie (school logo optional)
- Pupils can attend school wearing correct PE uniform on allocated PE days

Swimming - You will be advised when this is needed

- Plain one-piece swimming costume/trunks
- Swimming hat
- Towel

Forest School – You will be advised when this is needed

- Wellington boots
- Waterproof, warm outdoor clothing (eg: waterproof jacket and trousers or all-in one)
- Old clothes that can get muddy

We ask that all items of uniform – especially jumpers and cardigans - are clearly named so that if they are mislaid they can be returned to your child.

Jewellery

- We prefer children NOT to wear jewellery because of potential for accidents. However, small round 'ball like' silver/gold earring studs ONLY may be worn. These MUST be removed for PE/Games/Swimming.

Hair

- Hair which is longer than shoulder length MUST be tied back. We ask for no extreme hair colours or styles.

4.2 Where to purchase it

We offer Pre-Loved items of second hand school uniform, which can be requested from the Office.

5. Expectations for our school community

5.1 Pupils

Pupils are expected to wear the correct uniform at all times (other than specified non-school uniform days) while:

- On the school premises
- Travelling to and from school
- At out-of-school events or on trips that are organised by the school, or where they are representing the school (if required)

5.2 Parents and carers

Parents and carers are expected to make sure their child has the correct uniform and PE kit, and that every item is:

- Clean
- Clearly labelled with the child's name
- In good condition

Parents are also expected to contact Mrs Parsons, Headteacher, if they want to request an amendment to the uniform policy in relation to:

- Their child's protected characteristics
- The cost of the uniform

5.3 Staff

Staff will monitor pupils to make sure they are in correct uniform. They will give any pupils and families breaching the uniform policy the opportunity to comply and reminder letters for school uniform expectations will be sent to parents / carers. This will be followed up with the Headteacher if the situation doesn't improve.

In cases where it is suspected that financial hardship has resulted in a pupil not complying with this uniform policy, staff will take a mindful and considerate approach to resolving the situation.

5.4 School Standards Committee (SSC)

The SSC will review this policy and make sure that it:

- Is appropriate for our school's context
- Takes into account the views of parents and pupils
- Offers a uniform that is appropriate, practical and safe for all pupils

6. Monitoring arrangements

This policy will be reviewed every 2 years by the Headteacher. At every review, it will be approved by the SSC.
